RECOMMENDATION

5. That By-Law No. 2010-1 having been given three readings at this meeting, be approved.

On December 8, 2009, the Board approved a motion to realign the electoral boundaries for Ward F and H, as shown in APPENDIX III, to ensure that there continues to be a balanced electoral representation across the District for the 2010 Board election. The realignment shifts the communities of Brander Gardens, Brookside, Bulyea Heights, Ramsay Heights and Rhatigan Ridge from Ward H to Ward F. The Board election will be held in conjunction with the general municipal election Monday, October 18, 2010. The City Clerk has been advised of the approved realigned boundaries for Wards F and H.

In accordance with Section 262 (5 and 6) of the *School Act*, in order for this realignment of Wards F and H to be legally effective for the 2010 election, the Board must approve a by-law which, in effect, will request amendment of Ministerial Order 007/95 (APPENDIX II) which established the Board's current nine-ward boundaries and the Minister must approve the amendment by Ministerial Order by March 1, 2010. By-Law No. 2010-1 as set forth in APPENDIX I provides a written description of the realigned electoral boundaries for Wards F and H. A Ministerial Order once approved by the Minister is effective until amended, revoked or replaced.

BY-LAW NO. 2010 – 1

A BY-LAW RELATING TO AN AMENDMENT TO EDMONTON SCHOOL DISTRICT NO. 7 ELECTORAL WARD BOUNDARIES F AND H APPROVED BY MINISTERIAL ORDER 007/95.

That pursuant to section 262(5) of the School Act, the Electoral Ward boundaries for Wards F and H as outlined in respective sections 1(f) and 1(h) of Ministerial Order 007/95 is replaced as follows:

Ward F is bounded as follows:

On the north by 107 Avenue between Groat Road and 120 Street, southward to 106 Avenue, eastward to 119 Street, southward to 105 Avenue, eastward to 101 Street

On the east by 101 Street, southward to Rossdale Road, eastward to the North Saskatchewan River, southward to the Queen Elizabeth Park Road, further southward to 103 Street, further southward to the CPR track and further southward to Whitemud Drive Continue westerly along Whitemud Drive to the west boundary of the Whitemud Creek Ravine

Southward along westerly boundary of the Whitemud Creek Ravine to Oeming Road
Northward along Oeming Road to Bulyea Road
Southward along Bulyea Road to Rabbit Hill Road
Westerly along Rabbit Hill Road to Lane South of Promontory Point
Westerly to east boundary of SW 10-52-25-4
Southerly along the east boundaries of the adjoining properties to northern boundary of Transportation Utility Corridor

Westward along north boundary of Transportation Utility Corridor to North Saskatchewan River
Northward along North Saskatchewan River to Groat Road
Northerward along Groat Road to 107 Avenue

Ward H is bounded as follows:

On the north by Whitemud Drive between the west boundary of the Whitemud Creek Ravine to the CPR Track

On the east by the east boundary of the CPR tracks southward to the City limit; and
On the south by the City limit between the CPR track and the North Saskatchewan River

Northward along the North Saskatchewan River to the northern boundary of the Transportation Utility Corridor

Southward along the north boundary of the Transportation Utility Corridor to the south east corner boundary of the Environmental Reserve Lot adjoining the north boundary

Northward along the east boundary of the adjoining properties to the northeast corner of SW 10-52-25-4 and to the lane south of Promontory Point

East along the lane to Rabbit Hill Road

Southerly along Rabbit Hill Road to Bulyea Road

Northward along Bulyea Road to Oeming Road

Southward along Oeming Road to the west boundary of the Whitemud Creek Ravine

North along the west boundary of the Whitemud Creek Ravine to Whitemud Drive

MINISTERIAL ORDER (# 007/95)

The Edmonton School District No. 7

Electoral Ward Order

1 Pursuant to section 225(1) of the **School Act**, By-law No. 253 passed by the Board of Trustees of Edmonton School District No. 7, on January 10, 1995 is approved. The nomination and election of trustees shall be by wards as follows:

a) Ward A is bounded as follows:

- on the north by the city limit between St. Albert Trail and 82 Street;
- on the east by 82 Street southward to the Canadian National Railway (CNR) track;
- on the south by the CNR track westward to 149 Street, and
- on the west by 149 Street northward to St. Albert Trail and further northward to the city limit.

b) Ward B is bounded as follows:

- on the north by the city limit between 82 Street eastward to the North Saskatchewan River;
- on the east by the North Saskatchewan River southward to the CNR track;
- on the south by the CNR track westward to 82 Street; and
- on the west by 82 Street northward to the city limit.

c) Ward C is bounded as follows:

- on the west and north by the city limit between 79 Avenue to St. Albert Trail;
- on the east and north by St. Albert Trail southward to 149 Street and further southward to the CNR tracks, eastward to the Canadian Pacific Railway (CPR) track, southward to 107 Avenue, westward to Groat Road, southward to the North Saskatchewan River, and westward to Whitemud Drive; and

- on the south by Whitemud Drive westward to 149 Street, northward to 87 Avenue, westward to 170 Street, northward to Stony Plain Road, westward to 199 Street, southward to 79 Avenue and eastward to the city limits.
- d) Ward D is bounded as follows:
- on the north by the CNR track from the CPR track eastward to the North Saskatchewan River, and northward to the city limit;
 - on the east by the city limit southward to the North Saskatchewan River,
 - on the south by the North Saskatchewan River westward to Rossdale Road and further westward to 101 Street; and
 - on the west and south by 101 Street northward to 105 Avenue, westward to 119 Street, northward to 106 Avenue, westward to 120 Street, northward to 107 Avenue, westward to the CPR track and northward to CPR track.
- e) Ward E is bounded as follows:
- on the north by 79 Avenue between the city limit and 199 Street, northward to Stony Plain Road, southward to 87 Avenue, eastward to 149 Street, southward to Whitemud Drive, and eastward to the North Saskatchewan River;
 - on the east by the North Saskatchewan River; and
 - on the south and west by the city limit eastward and northward to 79 Avenue.
- f) Ward F is bounded as follows:
- on the north by 107 Avenue between Groat Road and 120 Street, southward to 106 Avenue, eastward to 119 Street, southward to 105 Avenue, eastward to 101 Street;
 - on the east by 101 Street, southward to Rossdale Road, eastward to the North Saskatchewan River, southward to the Queen Elizabeth Park Road, further southward to 103 Street, further southward to the CPR track and further southward to Whitemud Drive;
 - on the south by Whitemud Drive westward to the Whitemud Creek; and
 - on the west by Whitemud Creek northward to the North Saskatchewan River, further northward to Groat Road, and further northward to 107 Avenue.

g) Ward G is bounded as follows:

- on the north by the North Saskatchewan River between Rossdale Road eastward to the city limit;
- on the east by the city limit southward to 23 Avenue;
- on the south by 23 Avenue westward to 34 Street, northward to the Mill Creek, further northward to 50 Street, further northward to Whitemud Drive, and westward to the CPR track; and
- on the west by the CPR track northward to 103 Street, further northward to Queen Elizabeth Park Road, further northward to the North Saskatchewan River, and further northward to Rossdale Road.

h) Ward H is bounded as follows:

- on the west and north by the North Saskatchewan River between the south city limit northward to the Whitemud Creek, then southward to Whitemud Drive, and eastward to the CPR track;
- on the east by the CPR track southward to the city limit; and
- on the south by the city limit between the CPR track and the North Saskatchewan River.

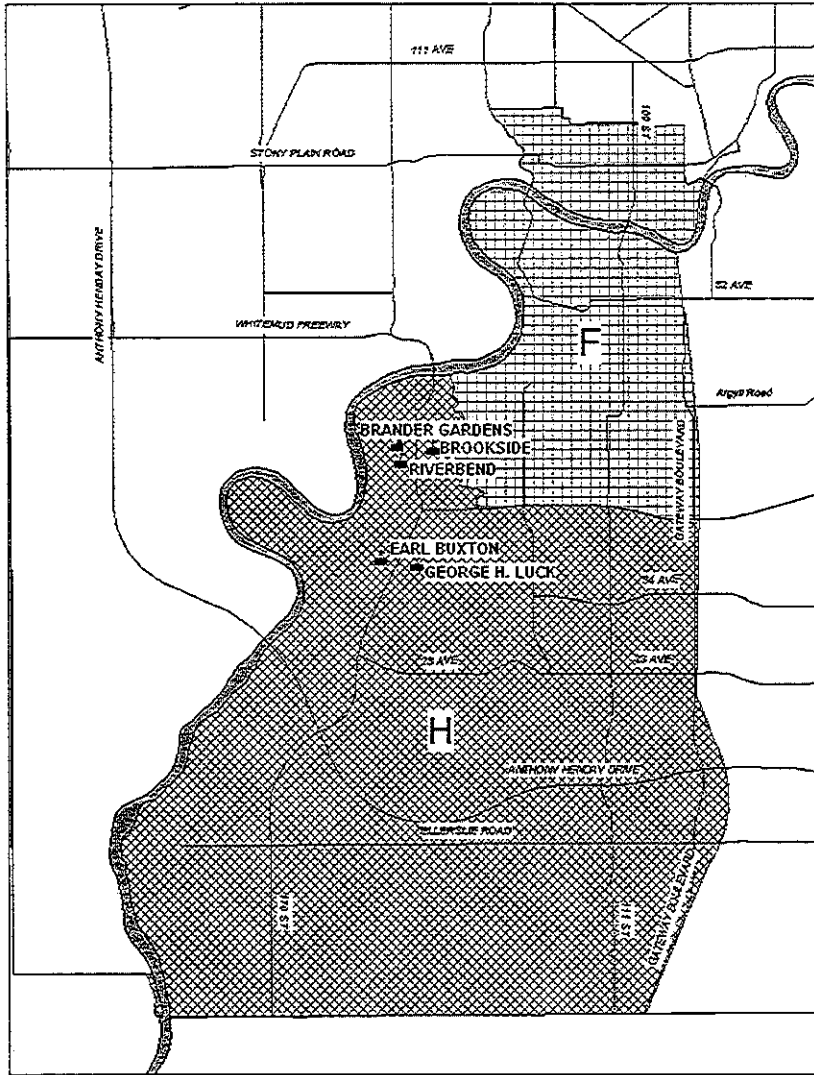
i) Ward I is bounded as follows:

- on the north by Whitemud Drive between the CPR track and 50 Street, 50 Street southward to Mill Creek, further southward to 34 Street, further southward to 23 Avenue and eastward to the city limit;
- on the east and south by the city limit between 23 Avenue and the CPR track; and
- on the west by the CPR track northward to Whitemud Drive.

2 The number of trustees to be elected to the Board of Trustees of Edmonton School District No. 7 is nine (9); one trustee is to be elected from each ward.

3 This order shall be in effect commencing with the 1995 local authorities election.
