D. <u>Communications from the Board Chair</u>

The Board Chair expressed gratitude and thanks, on behalf of the Board, to Trustee Estabrooks for her incredible service as Board Chair to students and families, the Division, the city and the province of Alberta. Trustee Estabrooks carried out the role with grace, humility, professionalism and with a fierce commitment to the value of public education. She has also been a mentor to the first-term Board of Trustees and showed them how to do the job of governance well. While Trustee Estabrooks has stepped down from the role of Board Chair to pursue other very exciting and worthwhile possibilities, the Board continues to look to her as an exceptional Trustee and an important member of their team. The Board Chair welcomed Trustee Estabrooks to provide her comments as outgoing Board Chair.

Trustee Estabrooks said she is humbled to have served alongside all the Trustees and said it has been quite an honour to be selected as the Board Chair from amongst her colleagues. She is looking forward to great things ahead for this Board under Board Chair Kusiek's leadership.

The Board Chair said October 2 was Custodial Staff Appreciation Day and October 5 was World Teachers' Day. We rely on the hard work of custodians every day to keep schools clean and contribute to a great learning environment. We look to teachers to guide students in their learning, inspiring young minds every day. On behalf of the Board, she offered heartfelt thanks to both staff groups.

The Board Chair shared that October 10 is World Mental Health Day. A key Division priority remains the well-being and mental health of students and staff. If anyone is struggling, please reach out to your network, a trusted friend or colleague, or one of the many available Division resources.

The Board Chair said last week was Read In Week. She thanked the schools that welcomed guests, and the many guests that visited students and shared their love of reading. She also thanked the students - for their questions, their enthusiasm, and for the fun surprises, like the "turkey tango" performance at one kindergarten classroom she visited.

The Board Chair stated that October is Learning City Month. Edmonton is the first Canadian city to become a member of the UNESCO Global Network of Learning Cities. Last year, the City of Edmonton successfully led a coalition of community partners, including Edmonton Public Libraries, the three school divisions/boards and eight post-secondary institutions to join the UNESCO Global Network of Learning Cities. The Board looks forward to showcasing the great learning happening at Edmonton Public Schools throughout the month of October.

The Board Chair shared that October is Latin American Heritage Month. Latin Heritage American Month was adopted in the House of Commons in 2018 and is meant to recognize the important contributions of the Latin American community, as well as to celebrate, share and promote their unique culture and traditions with all Canadians. Edmontonians of Latin American Heritage enrich our communities and our schools.

The Board Chair shared that October is also Islamic History Month. Results from our student demographic survey last year show that 16 per cent of students in grades 4-6 and 18 per cent of students in grades 7-12 identify as Muslim. Taking time to learn about Islam this month and throughout

the year, such as acknowledging days of significance in our multi-faith calendar, is an important part of ensuring that Muslim students, and all students, feel safe, welcome and that they belong.

The Board Chair extended gratitude to Minister Nicolaides for inviting Edmonton Public Schools to participate in an event with a delegation of Education Ministers from Germany. Superintendent Robertson and the Board Chair attended and learned more about how Germany structures vocational training for students. She also thanked Division staff for hosting representatives from Germany at Bannerman School to share the work the Division does on inclusion and supporting every student's pathway toward a life of dignity and fulfillment.

E. <u>Communications from the Superintendent of Schools</u>

The Superintendent congratulated Board Chair Kusiek on her election as Board Chair. He said the Division is thrilled to be working the her and continuing to serve this fine Board.

The Superintendent expressed a heartfelt gratitude of appreciation for the service of the former Board Chair, Trustee Estabrooks. He thanked her for navigating through some very complex times as the former Board Chair. The Division appreciated her support and her heart for kids in that work.

The Superintendent thanked Trustee Hole for taking on the role as the Board's representative on the Edmonton Public Schools Foundation (Foundation) Board of Governors. The Foundation's work is really important work to support Division kids.

The Superintendent congratulated Vice-Chair Sawyer on her election as Vice-Chair. He said the Division is looking forward to working with her and to continuing to serve this fine Board.

The Superintendent said that running for the office of Trustee is an incredible public service. The Division is large and complex, and the Board of Trustees all lead in various ways and as part of a team to help support the success of the Division's 115,000 students. He thanked the Board of Trustees and expressed congratulations to them once again.

The Superintendent shared that the official enrollment numbers, as of September 30 count, are 115,176 students welcomed into Edmonton Public Schools. This represents approximately a five per cent increase, and it's only about half a per cent over what the Division projected. He expressed his appreciation to Division staff working through those projections and their incredibly accurate work. The increased enrolment numbers have implications for the weighted moving average. He thanked Mr. Burnstad, in Financial Services, for ensuring the Division isn't underrepresented in that weighted moving average or overrepresented terribly. The Superintendent said that although the Division is very short on space, the Division welcomed our kids and wants to make sure that everyone has a great start to the school year.

The Superintendent expressed his appreciation to the many parents who reached out in appeal for spots in schools that they wanted to choose for their families. The Division carefully considered each and every one of those appeals. And if he had his wish everyone would get to choose exactly where it is they want to learn in Edmonton Public Schools but the Division is just under a lot of space pressure right now, in certain areas

of the city. He appreciates everyone's patience, and the work of Division Support Services as they've navigated some complexities with our parent community.

The Superintendent advised that school councils are busy organizing for the year and said it's great to see that many are already up and running. School councils play a vital role in supporting our students and making connections between the school parents in the larger community. He expressed appreciation to the Board for providing school council memberships for all Division schools once again this year. The Division is co-hosting with Alberta School Councils' Association, an online training session for school council volunteers on October 24 and the registration deadline is October 16; for further details visit <u>epsb.ca</u>.

ISSUE

The Student Senate is presenting their work plan for the 2023-2024 school year to the Board of Trustees.

BACKGROUND

The Student Senate serves as a youth engagement model to promote active student participation in youth governance within education and to provide the Board of Trustees with a meaningful way to access student voice. To help focus the direction and energy of the Student Senate, they establish a yearly work plan that focuses on real-life application projects that are informed by the voice of their peers. The Student Senate reports on their efforts to meet their work plan goals at three public Board meetings throughout the year.

In the spring of 2023, Edmonton Public high schools selected up to two students per high school to provide representation on a 2023-2024 Student Senate. The 2023-2024 Student Senate met on September 20 and 27, and October 11 to complete the following tasks:

- Elect three Student Trustees
- Elect four Student Senate Executives
- Identify the themes and channels for their project work this year.

CURRENT SITUATION

To help ensure their work would meet the needs of their peers, the Student Senate reviewed data collected from a survey conducted in the previous school year (2022-2023). This survey was available to all high school students in the Division and asked students to answer the following question: Considering your school experiences, what supports or opportunities would enhance pathways for your success? The survey collected 2, 156 responses in only five days (October 3, 2022 to October 7, 2022).

After reviewing the available data, students were asked to complete a Google Form ranking a variety of project ideas. The responses led to the formation of four initial working groups: Podcast, Networking (group, forum, event, etc.), Media (brochure, poster, etc.) and Mixed (workshops, promotion, etc.).

At the October 11, 2023, Student Senate meeting, students worked in their preferred working groups to begin developing a preliminary plan for a project of their choice. To support this work, students completed a "Frames of Reference" activity. This activity invited students to consider the following questions:

- What goals and priorities from the Division's Strategic Plan does our project address?
- Is the scope of the work we are planning to pursue within our locus of control?
- What steps need to be taken to ensure we can complete this project within the provided time frame (November 2023 to May 2024)?

The next Student Senate meeting is on November 8, 2023. At this meeting, students will continue refining their project plans with the support of an advisor using a SMART goals planning tool.

In the 2023-2024 school year, the Student Senate will also be providing youth perspective to Board and Division initiatives. Throughout the year, the Board and Division Administration will be able to access youth voice through the Student Senate about a broad range of topics relevant to high school students.

KEY POINTS

- Student Senators elected three Student Trustees and four executive members.
- Student Senators selected a working group to join (Podcast, Networking, Media or Mixed).
- The Student Senate will provide youth perspective to the Board of Trustees and Division Administration about a range of topics throughout the year.
- Student Trustees will report their progress towards their work plan goals at the February 20, 2024, public Board meeting.

ISSUE

The Board approved the following recommendation at the March 3, 2015, Board meeting: That Section 5.4 of the Trustees' Handbook be revised to give the Caucus Committee final decision-making power on certain types of matters, and yet constrain that power so it is used only when absolutely necessary.

The following recommendations were approved at the October 10, 2023, Caucus Committee meeting:

1. <u>Disposition of a Portion of the Parkdale School Site</u>

That the disposition of the north portion of the Parkdale School site be approved.

That administration be authorized to execute the required agreements with the City of Edmonton and EPCOR on behalf of the Division, be approved.

BACKGROUND

The Division's Real Estate Strategy, approved by the Board of Trustees on February 15, 2022, identifies the Parkdale School site for potential disposition. This partial disposition of the Parkdale site aligns with the Division's Real Estate Strategy. The portion of the site north of the existing building has been identified as suitable for installation of a stormwater management facility (dry pond) by EPCOR.

2. <u>Surplus Declaration of a Portion of the Virginia Park School Site for Concordia University of</u> <u>Edmonton Parking Lot</u>

That the Board of Trustees declare a portion of the Virginia Park School site as surplus to Division needs, be approved.

BACKGROUND

Concordia University of Edmonton (CUE) has expressed an interest in acquiring a portion of the Virginia Park School parking lot and landscaped boulevard.

3. <u>Proposed City Partnership for Glenridding School</u>

That Administration continue to explore partnerships at the recently announced Glenridding Heights 7-12 School.

BACKGROUND

Given Alberta's design efforts within a P3 model Administration will continue to explore partnerships to enhance the facility.

4. <u>Confucius Institute Edmonton (CIE) Memorandum of Understanding Signing</u>

That the Board of Trustees authorize the Board Chair to sign the CIE renewal agreement.

BACKGROUND

The signed agreement supporting the Confucius Institute Edmonton is up for renewal.

 - Raise awareness of the benefits of making space within existing inventory or building new spaces to enhance career-focused programming
 - o Bring attention to need for modulars, as well as a more transparent process for their acquisition

- Champion improvements to the playground construction and renewal process
 - Work with the partners including parent groups, the City of Edmonton, Province of Alberta and advice of Division staff to streamline processes and overcome challenges to the current playground construction and renewal process
- Explore options for alternative infrastructure funding

ISSUE

In accordance with Section 11.5 of the Trustees' Handbook, the Board Chair is granted an annual discretionary expense allowance for expenses incurred related to the role of the Board Chair. The Board Chair is required to provide a written annual report outlining the nature and purpose of expenses incurred under the Board Chair Discretionary Expense Allowance.

BACKGROUND

Effective October 22, 2013, the Board approved granting the Board Chair an annual discretionary expense allowance of \$2,153.80 to cover expenses incurred related to the role of Board Chair.
