Tân'si, tungasugit. Greetings in Cree and Inuktitut. The Board Chair called the meeting to order with recognition that we are here meeting on Treaty 6 Territory of which amiskwaciwâskahikan or Edmonton or Beaver Hills House is a part of. This land has and continues to be inspirational and important to the Cree, Saulteaux, Blackfoot, Métis, Dene and Nakota Sioux. She ended the land acknowledgement recognizing that we are in fact all Treaty people.

A. O Canada Recognition of National Indigenous Peoples Day

Ms. Sheila Williams, a consultant with the Division, sang O Canada in Cree.

Mr. Shaun Lafferty, Supervisor with Curriculum and Learning Supports, spoke and shared two videos. One video highlighted the significance of offering protocol in Indigenous culture and the second video shared an Indigenous coyote story.

D. <u>Communications from the Board Chair</u>

The Board recognized that Wednesday is National Indigenous Peoples Day which falls on June 21, the summer solstice, the day with the most daylight in the year. This is a day to celebrate and honour Indigenous heritage, diversity, culture and languages of First Nations, Inuit and Metis peoples. Ahead of this important day, Canada Post unveiled a stamp with one of our school's namesakes, Metis educator and former senator Thelma Chalifoux, late last week.

The Board Chair shared that many of our students are attending the National Indigenous Peoples Day school event for K–12 students at Fort Edmonton Park today. The day includes cultural and educational activities, games, land-based learning, crafts and performances with representation by many diverse First Nations, Inuit, and Métis peoples. This day of Indigenous learning is a collaboration between the City of Edmonton, Edmonton Public Schools, Edmonton Catholic Schools, Fort Edmonton and MacEwan University.

The Board Chair expressed thanks to everyone who helped make the official opening of Joey Moss School such an amazing celebration. It was a great evening hearing stories about Joey Moss and all that he did to inspire so many Edmontonians. She thanked Principal Marshall, and the staff and students at Joey Moss School for the warm welcome and for hosting an event that Joey himself would have loved.

The Board Chair recognized that June is Pride Month and although Pride Week was held earlier this month for Edmonton Public Schools, she wished a happy Pride Month to everyone. This is a month dedicated to uplifting, celebrating and supporting the rights of the 2SLGBTQIA+ community. She said that when we all feel welcome, safe and included we all benefit.

The Board Chair thanked the new Minister of Education, Demetrios Nicolaides, for reaching out to her and Superintendent Robertson. They had a good meeting and appreciated the time and the questions that the Minister had for them. The Board Chair said they talked about working together collaboratively in support of students.

On behalf of the Board, the Board Chair thanked all staff and Superintendent Robertson for putting their heart and soul into serving students and their families this past school year. She said that as we emerge from a once in a lifetime global pandemic, she is so grateful to serve with a school division that cares so deeply about students and works tirelessly to enhance pathways for student success. On behalf of the Board, she wished everyone a wonderful and well-deserved summer break.

E. <u>Communications from the Assistant Superintendent of Instructional and</u> <u>Strategic Division Supports</u>

Assistant Superintendent Muhlethaler shared that this past year has been a complex year coming off the pandemic. It has been a heavy year where we've addressed so much loss in the Division, whether it's our students, our parents or colleagues. She said that one thing she can say, on why she has been with the Division for so long is because the Division cares so much about each other. When we have staff that are impacted by loss in their school community, our colleagues surround them, embrace them, and support them however they can, to get them through what they're dealing with. She said that this is why she can say that she's very proud to be a member of the Division.

Assistant Superintendent Muhlethaler said that it's been a tough budget year as well. She commended Division leaders for working on the budget and ensuring that our students have the supports that they need.

Assistant Superintendent Muhlethaler stated that the Division accomplished a lot this year, with the work around anti-racism, reconciliation and equity, and the growth that the Division has seen from the Equity Achievement Project. The student growth has been just phenomenal and we've had the first ever demographic survey. Our Division is grounded in our cornerstone values, in collaboration you see that everywhere and it's the work that we do together that we can do the work that we do. We're committed to kindness and we have a drive to ensure that everyone in our school division feels that sense of belonging.

Assistant Superintendent Muhlethaler thanked the Board for their steadfast support of public education and the Division. She expressed hope that all the Trustees take the time as well this summer to decompress, reenergize and enjoy their summer with their loved ones.

Assistant Superintendent Muhlethaler shared that the Division is looking forward to next year and will welcome 114,000 students in the fall. She expressed well wishes, on behalf of Superintendent Robertson, a wonderful summer break for all families, students, staff, Trustees and Division leaders.

J. Other Committee, Board Representatives and Trustee Reports

Trustee Nelson congratulated students, staff and families in the Balwin community who competed in a competition with schools across Canada and the US. They received the most votes and won the \$20,000 prize to create a new, welcoming, safe and inclusive outdoor space, which will be enjoyed by community members and the school community.

Trustee Kusiek shared a quick note of gratitude to the staff, students, parent volunteers and the school community for all that they do. She shared that she has been out to schools in Ward F more than 50 times this year. She expressed thanks for sharing their school days with her and said it's the best part of the job of Trustee. Her appreciation to everyone else who also worked hard for kids every day, including the central staff and wider community. She said it has been great to get out to these events of celebration as well, and thanked everyone for the excellent work they do.

Trustee O'Keefe shared an Edmonton Public Schools Foundation (Foundation) update. The Foundation's Reading for Life Read-A-Thon wrapped up on May 31. Thanks to all of those who enjoyed a good book (or many good books!) over the course of the month. The Foundation staff are excited to share that our community tracked having read more than 16,000 books. The schools across the Division came together to raise an incredible \$31,000. The Foundation is so grateful for everyone's support of this important fundraiser - especially the continued support of both Jayman BUILT and EPCOR who made this year's fundraiser event even bigger and better than last year. They can't wait to read with everyone again during next year's Reading for Life Read-A-Thon - May 2024, mark your calendars.

Trustee O'Keefe thanked all those who attended the PSAA's 32nd annual Bids for Kids event last month and last week's annual golf tournament. Those two events raised more than \$12,000 to benefit the Foundation. Next year's Bids for Kids event is scheduled for May 3, 2024.

Trustee O'Keefe shared that on June 1, the Foundation launched the expansion of the Fresh Hoops program at Delton School. A huge thank you to the Delton Dragons for being such amazing hosts. Not only did they celebrate the opening of their incredible new outdoor basketball court with a ribbon cutting, popsicles and some one-on-one basketball with the Edmonton Stingers, they also announced a generous donation that will revitalize these important community spaces across Edmonton. The Foundation is so grateful and proud to share that local company, Go Auto, has donated an initial \$500,000 to kick-start work on our courts right away, AND an additional \$500,000 to match community donations that come in for Fresh Hoops between now and August 2025. If successful, the potential total donation of \$1.5 million would enable us to revitalize approximately 75 courts across Edmonton Public Schools - serving not only our students, but community members across the city. Trustee Hancock shared that the Alberta School Boards Association (ASBA) held their Spring General Meeting on Monday, June 5, 2023. She thanked her colleagues Trustees Estabrooks, Sawyer and Sumar for attending with her. She shared that during the business portion of the meeting, three emergent position statements were presented to members for discussion and voting. Those that are approved, ASBA will submit as advocacy to the provincial government on behalf of the members. Trustee Hancock reported back on each statement and the results.

Position Statements

- 1. Equitable Funding for Displaced Students, Refugee Students, and Refugee Claimants
 - Sponsored by EPSB
 - Trustee Sumar introduced the position statement
 - A friendly amendment adding the words "at a minimum" preceding 5 years of funding was recommended
 - With the amendment the motion was carried.
 - The final version of the position statement is as follows:

BE IT RESOLVED THAT, the Alberta School Boards Association advocate to the Provincial government:

- That all students who are identified as "refugee students", "students claiming refugee status", "Canada-Ukraine Authorization for Emergency Travel (CUAET) displaced students", and "non-CUAET displaced students" have access to equitable funding based on their need and not on country of origin.
- 2. That students who are identified as "refugee students" receive the second count date and prorated funding equal to that of those defined as "CUAET displaced students" in addition to

continuing to have access to, at a minimum, five years of Refugee or English as an Additional Language funding.

- 3. That students who are identified as "students claiming refugee status" receive all funding equal to that of those defined as "refugee students", and the second count date and prorated funding equal to that of those defined as "CUAET displaced students".
- 4. That all students who are identified as "CUAET displaced students" be eligible for, at a minimum, five years of funding equal to that of those defined as "refugee students".
- 5. That students who are identified as "non-CUAET displaced students" receive all funding equal to that of those defined as "refugee students", and the second count date and prorated funding equal to that of those defined as "CUAET displaced students".
- 2. Per Student Per Subject Curriculum Implementation Funding
 - Sponsored by Black Gold School Division
 - EPSB voted in favour of this position statement.
 - The motion was carried.
 - The final version of the position statement is as follows:

BE IT RESOLVED THAT, the Alberta School Boards Association advocates for the Government of Alberta to shift to per student per subject funding for Curriculum Implementation Resource funding based on actual student enrollments beginning in September 2023, and moving forward, for teaching and learning resources required to implement the new Curriculum, thereby ensuring equity of resource funding for all students and encouraging more optional implementation.

- 3. Curriculum Advocacy
 - Sponsored by Zone 2/3
 - EPSB submitted an amendment to this position statement to include the word "meaningful" to consultation and collaboration, and that both stakeholders and school boards would be consulted on curriculum implementation and on further development.
 - With the amendment, the motion was carried.
 - The final version of the position statement is as follows:

BE IT RESOLVED THAT, The Alberta School Boards Association advocates for the Government of Alberta to continue meaningful consultation and collaboration with stakeholders and school boards on curriculum implementation and on any further curriculum development. Further, that the Government of Alberta advance curriculum implementation one grade at a time effective the 2023/24 school year.

That the Caucus Committee approve the execution of the finalized purchase agreement, by the Board Chair on behalf of the Division, to acquire Alberta College from MacEwan University.

BACKGROUND

Centre High has been operating within a portion of Alberta College since September 2020. The current lease with MacEwan University expires on August 31, 2023. When the lease was executed, a nonbinding "Letter of Intent" was entered into regarding the exploration of the potential sale of the property to Edmonton Public Schools.

On September 6, 2022, the Board of Trustees authorized administration to execute a non-binding Memorandum of Understanding on behalf of the Division to acquire Alberta College from MacEwan University. The Memorandum of Understanding was endorsed on November 1, 2022.

External legal counsel for the Division and MacEwan University are finalizing a purchase agreement for Alberta College based on the terms contained in the non-binding Memorandum of Understanding approved by the Board of Trustees.

2. Exempt Staff Terms and Conditions of Employment

That the amended terms and conditions of employment for both non-management and management exempt staff be approved.

BACKGROUND

The previous 2017 update was reasonably substantive, with the objective being a more broad and complete review.

The current update is more limited and has been carried out primarily to ensure the document's currency and to consider more modest changes that have been identified over the past several years.

3. Proposed Trustees' Handbook Updates

That Sections 2.2, 2.5, 2.6 and 2.7 be updated to reflect current information.

That Section 13.5 General and Professional Liability Coverage of the Trustees' Handbook be deleted in its entirety and the following sentence be added to Section 13.4 Insurance and Indemnification:

The Division also carries appropriate levels of Commercial General Liability and Professional Liability Insurance for the Board of Trustees.

BACKGROUND

The Handbook serves as a single point of reference for all Trustees and sets the foundation for common understanding for the Trustees, the Superintendent of Schools and the Administration about its own operations, procedures, practices, and conduct as a school board.

The Handbook includes expectations and procedures for individual Trustees, both as members of the Board and as representatives of the communities that elected them. Trustees are expected to govern themselves accordingly.

May 26, 2023 Edmonton Public School Board Re: 2023 Superintendent Evaluation

We have completed the 2023 Superintendent Evaluation of Mr. Darrel Robertson ("the Superintendent") as requested by the Board of Trustees of the Edmonton Public School Board. Our comprehensive evaluation was comprised of a 360-degree review including all Trustees, the Division Support Team and the Division Leadership Team. A mix of interviews via teleconference and on-line surveys were used to collect the feedback from a total of 185 participants. An overall recap of the results was prepared for the Board. Data collection for the in-depth interviews began during the week of April 12 and concluded on May 8, 2023. Prior to the interviews, Trustees and Division Support Team members completed a survey where they rated the Superintendent on his performance related to the indicators in Alberta Education's Superintendent Leadership Quality Standard.

The Superintendent achieved an overall rating of 4.6 on a scale of 1 to 5. This represents a rating in the outstanding range. The Superintendent is perceived to be an exceptional leader by the Board, the Division Support Team and the Division Leadership Team. He is a solution-focused, collaborative leader who approaches challenges with fact-based decisions.

The Superintendent allocates the division's budget to put the needs of students first. He is always available to provide support and guidance but trusts individual principals to manage the needs of their schools. He embodies the core values of integrity, equity, collaboration, and accountability. He clearly and consistently articulates the vision and demonstrates a dedication to student improvement and achievement.

The opportunities for the Superintendent to develop were succession planning and strengthening the capacity of all central team members. As the division emerges from the pandemic, it is also an important time to strengthen and deepen relationships with existing internal and external stakeholders, as well as explore opportunities for new relationships in this regard.

In summary, the Superintendent continues to be seen as an outstanding leader, with very positive feedback across all stakeholder groups.
